- Deka Immobilien entered into a JV with VGP after securing a 50% stake in a logistics portfolio in Germany with a total value of around €1.2 billion.
- LGIM, via its dedicated UK and European real estate debt division, provided a £400 million loan to Unite.
- Landsec and British Land have called for changes to the UK planning system to support brownfield urban regeneration which would result in more growth, jobs, and homes in the UK.
- Hines has raised an additional €305 million of equity for the Hines European Value Fund 3.
- Goodstone Living secured over £100 million of debt financing and appointed a construction partner to support the delivery of the UK's largest modular BTR residential community in Birmingham.
- The London borough of Tower Hamlets has given permission for the development of an 823,000 sq. ft. life sciences lab and workspace project.
- Achmea Real Estate received two mandates totaling €117 million from a Dutch insurer for its Achmea Dutch Retail Property Fund.
- Cromwell Property Group entered into an agreement to create a joint venture with Hong Kong-based asset manager Value Partners Group, exchanging on the sale of a 50% stake in the Cromwell Italy urban logistics fund assets.

- Greencoat UK Wind and Schroders Greencoat have acquired a 25% stake in the 630-MW London Array Offshore Wind Farm for c. £717 million.
- Prosolia Energy, the Spanish solar developer, has agreed a €255 million debt financing facilitated by US institutional investor, EIG.
- Ardian has acquired Attero, the Netherlands waste management business, for €215 million.
- DIF Capital Partners has invested £200 million in Field to develop grid-scale battery energy storage projects in the UK and Western Europe.
- Aviva has acquired an initial 35% shareholding in Innovo Renewables, the vertically integrated Italian renewable energy business, for an undisclosed amount.
- Digital Realty has acquired 26,000 sqm of land in Amsterdam to expand its existing Amsterdam Schiphol data centre campus for an undisclosed amount.
- NorthC Group has purchased a data centre near Zurich for an undisclosed amount in a sale/partial-leaseback deal.

- KGAL has invested a total of €1.3 billion for its KGAL ESPF 4 fund which manages a portfolio of 33 European wind and solar parks.
- The high demand for data centre capacity and limited supply of power is causing low vacancy levels and rising rents, according to a report from CBRE.
- Sunrock has installed a 120,000 sqm photovoltaic system on the roof of PATRIZIA's Maasvlakte logistics development, which has the
  potential to produce 25 Megawatt peak (MWp) p.a. of clean energy.
- Acciona Energia, the Spanish renewables company, increased profits by 4% in H1 2023.
- Cellnex reported revenue of more than €2 billion in H1 2023 compared with €1.69 billion in H1 2022.
